TO: Parent/Guardian

The Upper Dauphin Area Elementary School will be holding Kindergarten Registration/Screening for the 2022-23 school year for any child who has not started school and will be five (5) years of age on or before September 1, 2022.

Registration/screening will be held on Tuesday, April 26, Wednesday April 27 and Thursday April 28, 2022. Registration will be held on each day from 8:30 AM to 3:00 PM. Please call the Upper Dauphin Area Elementary School at 717-362-4511 to make an appointment for registration. Please plan on being at registration for one (1) hour.

On the above dates, occupational therapy, speech, vision and kindergarten readiness screenings will be given to your child. Parents should bring:

- Your child
- Child's birth certificate
- Immunization records (requirements as shown below)
- A copy of your child's most recent physical examination
- Proof of residency(requirements as shown below)

The Commonwealth of Pennsylvania has school immunization requirements. The regulations require children entering kindergarten for the 2022-23 school year have the following immunizations:

- Three doses of hepatitis B vaccine
- Four doses of polio with 4<sup>th</sup> dose administered on or after one's 4<sup>th</sup> birthday
- A second dose of measles vaccine, preferably given as Measles, Mumps, Rubella(MMR)
- A fourth dose of tetanus and diphtheria vaccine, including one dose administered on or after one's 4<sup>th</sup> birthday
- Two doses of Varicella (chickenpox vaccine)

Proof of residency will be required at your registration appointment in order to finalize your child's enrollment. Please review the list of required documents. Contact the Elementary School Office if you have any questions. Proof of residence in the Upper Dauphin Area School District is defined as:

- A Pennsylvania Driver's License, Pennsylvania Photo Identification Card or Passport containing your current address within the UDASD.
- One (1) of the following:
  - Deed, settlement document, sales agreement, a lease or notarized affidavit showing occupancy of a residence within the Upper Dauphin Area School District.
- If you do not have any of the documents listed above, then you must present two (2) of the following:
  - Proof of property tax return indicating the address within the UDASD.
  - Current check stub for wages, public assistance, social security or other source of income indicating the address within the UDASD.
  - Payment or proof of liability for payment for municipal or school district taxes for an improved property within the UDASD.
  - Current utility bill indicating payment for a utility due to occupancy of a residence within the UDASD.
